

# President's Report | 2016

## University Highlights Fiscal Year 2016

(July 1, 2015-June 30, 2016)

- » Entered Phase 4 (Titled: Impact) of the 20/20 plan that was initiated in 2006. The next five-year plan includes a contemporary exceptional educational program for the DCP, new student housing, extension of our programs to Europe, significant increases in students, expansion of educational degrees and enhanced clinical experiences, just to name a few initiatives.
- » Appointed Rob Scott, D.C. as Provost.
- » Appointed of Dr. Jana Holwick as the new Dean of the College of Graduate and Undergraduate Studies.
- » Finished the year with revenues of \$1.2 million less than budgeted and expenses \$4.0 million less than budgeted, producing a net positive financial performance against budget.
- » Eleventh consecutive year that financial performance was better than budgeted.
- » Surpassed more than 5,000 alumni and friends getting engaged with LIFE activities and programs.
- » At the 2015 Fall CElebration, hosted 1,650 alumni and friends on campus for continuing education, reunion events and parties.
- » Implemented new state partnerships with the New York Chiropractic Council and Georgia Chiropractic Association.
- » Completed Phase 1 fundraising goal of \$5 million for the William M. Harris Center for Clinical Education.
- » Received \$120,000 contribution from The Laughing Gull Foundation to support the Chillon Project (degree program for incarcerated individuals).
- » Received handheld lasers valued at \$43,600 from Erchonia Corporation.
- » Received spinal pelvic stabilizers valued at \$41,503 from Foot Levelers Inc.
- » Announced intercollegiate men's soccer, women's soccer and women's basketball as new sports starting in Fall 2016.
- » President Guy Riekeman, D.C., presented with New Beginnings Chiropractic Lifetime Achievement Award.
- » Added Bachelor of Science in Culinary Nutrition as new degree enrolling in Fall 2016.
- » Launched The Chillon Project, a degree-granting program for incarcerated students and correctional staff in the Georgia prison system.

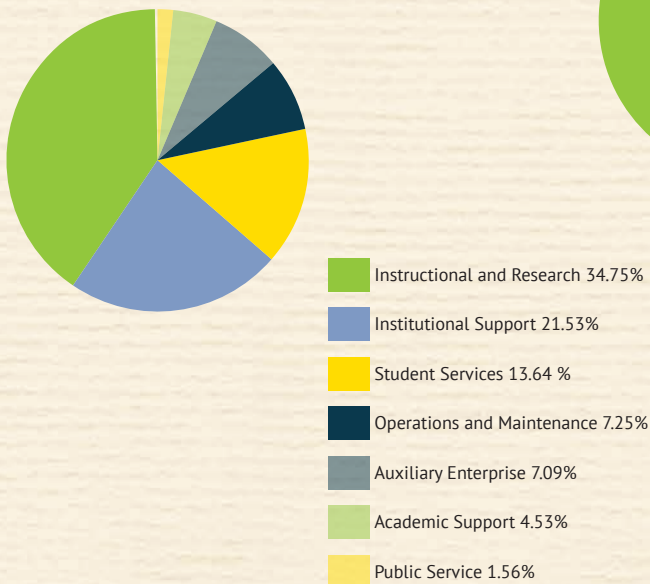

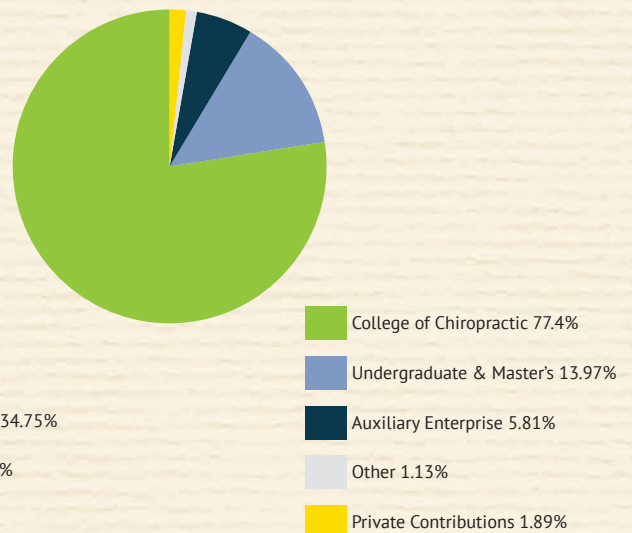
